WCBC approved the submission of the Deposit LDP, the Schedule of Proposed Focussed and Minor Editing Changes and supporting documents on 22<sup>nd</sup> November 2018.

Consultation on the **Schedule of Proposed Focussed and Minor Editing Changes** will take place for a 6 week period between **Monday 7<sup>th</sup> January and Monday 18<sup>th</sup> February 2019.**
